<b>Removal goods</b>	<ul style="list-style-type: none"> <li>▪ Truthfully completed and signed application form.</li> <li>▪ Exemption permit household items, vehicles, vessels, moto.</li> <li>▪ A clear photocopy of your Passport (page photo and name).</li> <li>▪ Import tax exemption.</li> <li>▪ Request deregistration population register - municipality last living Netherlands (copy is sufficient).</li> <li>▪ Certificate of Residence.</li> <li>▪ Inventory.</li> </ul>		<ul style="list-style-type: none"> <li>▪ Customer does not have to be present at customs clearance of household goods.</li> <li>▪ Used household goods and personal effects are duty-free if they have been owned and used by the Customer for over six months.                             <ul style="list-style-type: none"> <li>▪ However so called "borgstelling" has to be paid and will be refunded after Sedula and Tax Form has been handed over to destination agent (copy is sufficient).</li> </ul> </li> <li>▪ Customer must contact Destination Agent upon arrival.</li> </ul>
<b>Restricted items</b>		<ul style="list-style-type: none"> <li>▪ All new items (invoice required).</li> </ul>	
<b>Prohibited items</b>		<ul style="list-style-type: none"> <li>▪ Drugs and narcotics.</li> <li>▪ All weapons are subject to a special license.</li> </ul>	
<b>Pets</b>	<ul style="list-style-type: none"> <li>▪ Health Certificate from veterinarian required.</li> </ul>
