Restricted and prohibited items		<ul style="list-style-type: none"> ▪ Prohibited or very restricted items include: <ul style="list-style-type: none"> ▪ drugs, ▪ flammables, ▪ toxins, ▪ poisons, ▪ explosives, ▪ firearms, ▪ ammunition, ▪ radioactive material, ▪ corrosives ▪ etc. ▪ Regulated, restricted and dutiable items include: <ul style="list-style-type: none"> ▪ plants, ▪ high-value artwork, ▪ food, ▪ liquids, ▪ medicinal products, ▪ alcohol, etc.
